Vista Verde provides supports for Vista Verde supports second language learners by creating Structured English Immersion (SEI) clusters within each grade level. These clusters consist of five to six students within the class that are learning English. The classes that have these clusters are supported by an additional instructional aide that attends to the needs of our English language learners. Vista Verde will offers an after school extended learning program (ELOP) that targets the instructional needs of our SEI students. Furthermore, Vista Verde offers parent education to assist parents in assimilating and adjusting to a new cultures and educational system.

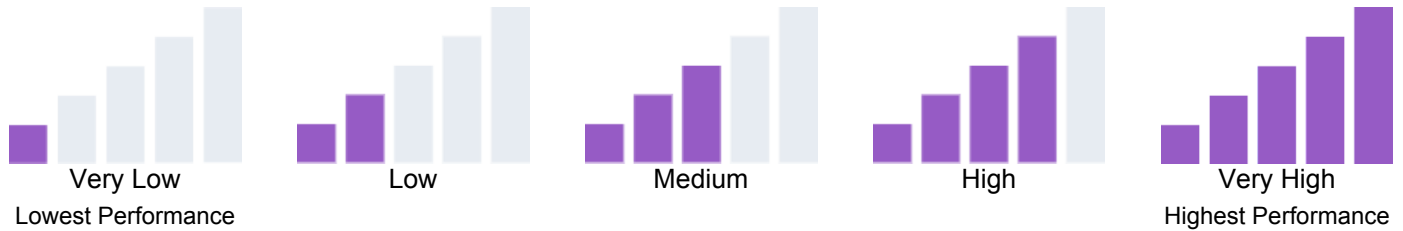

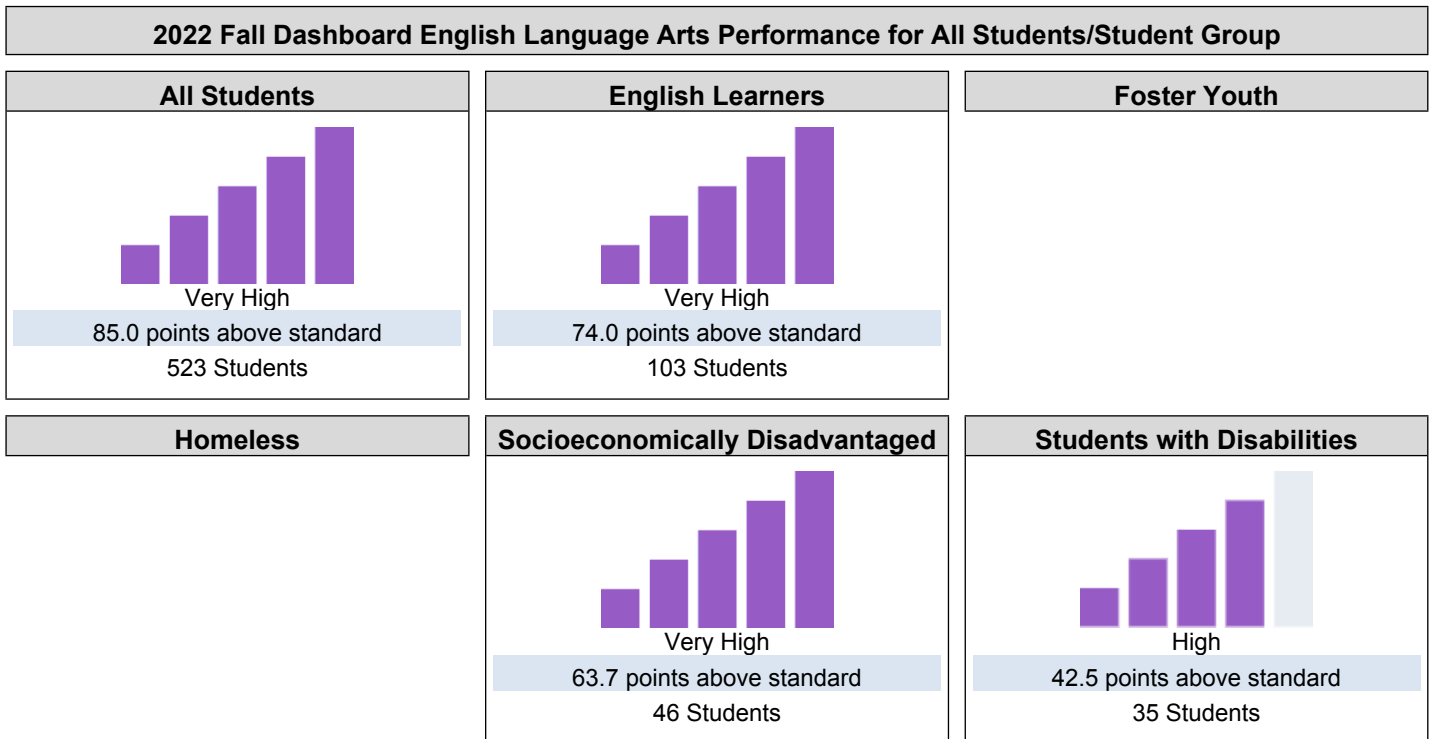

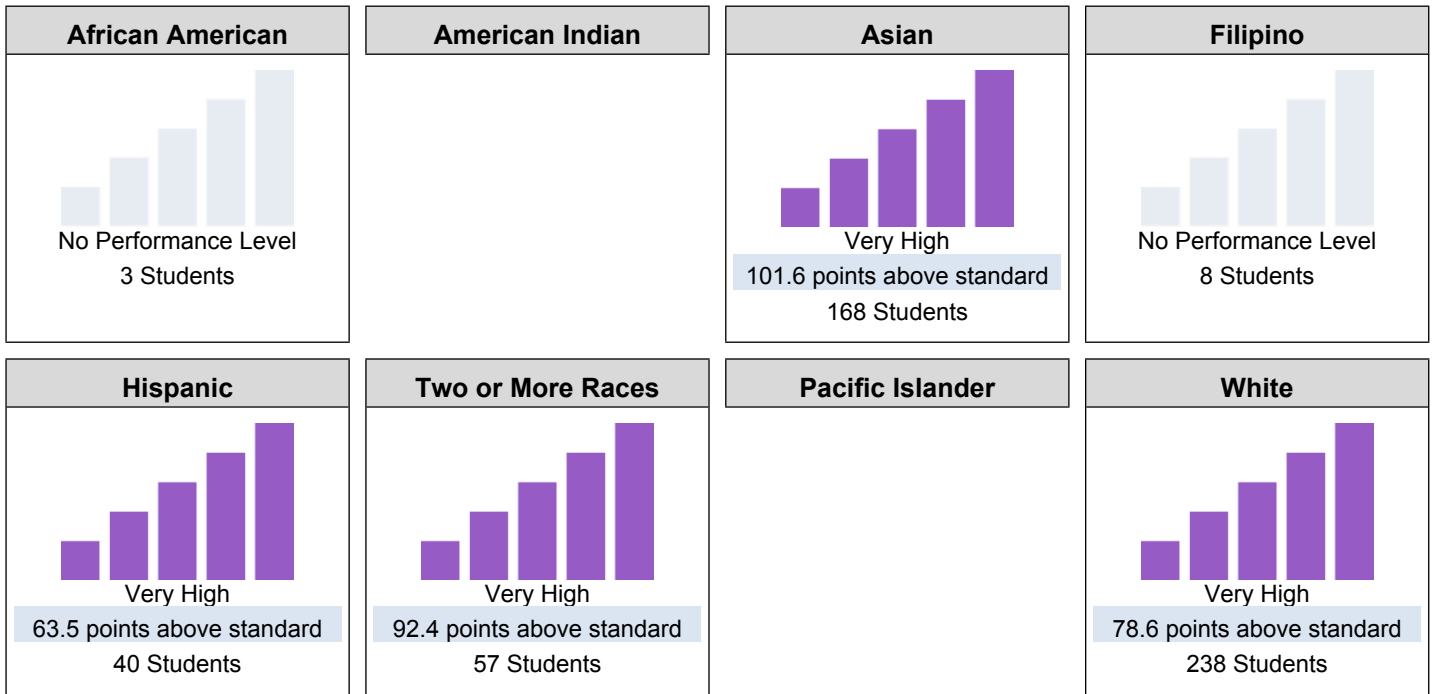

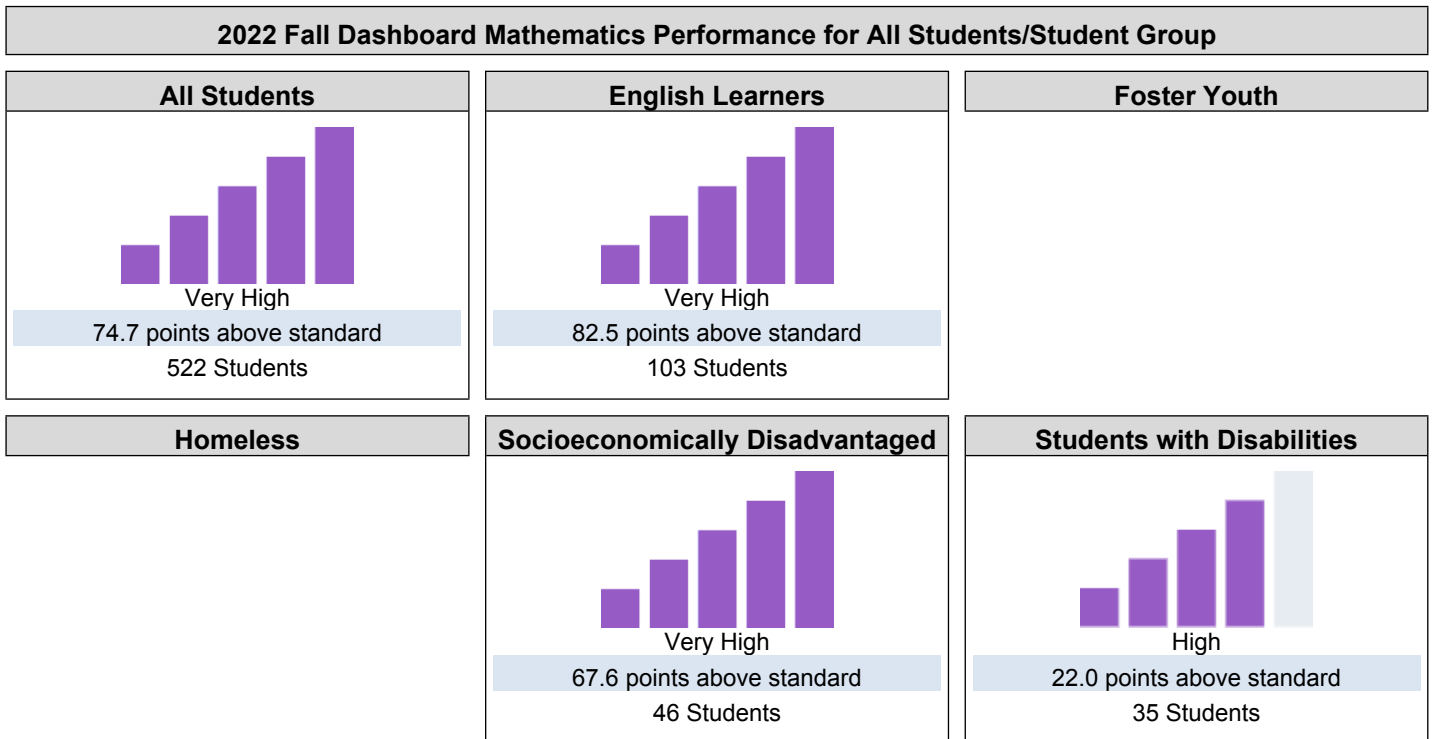

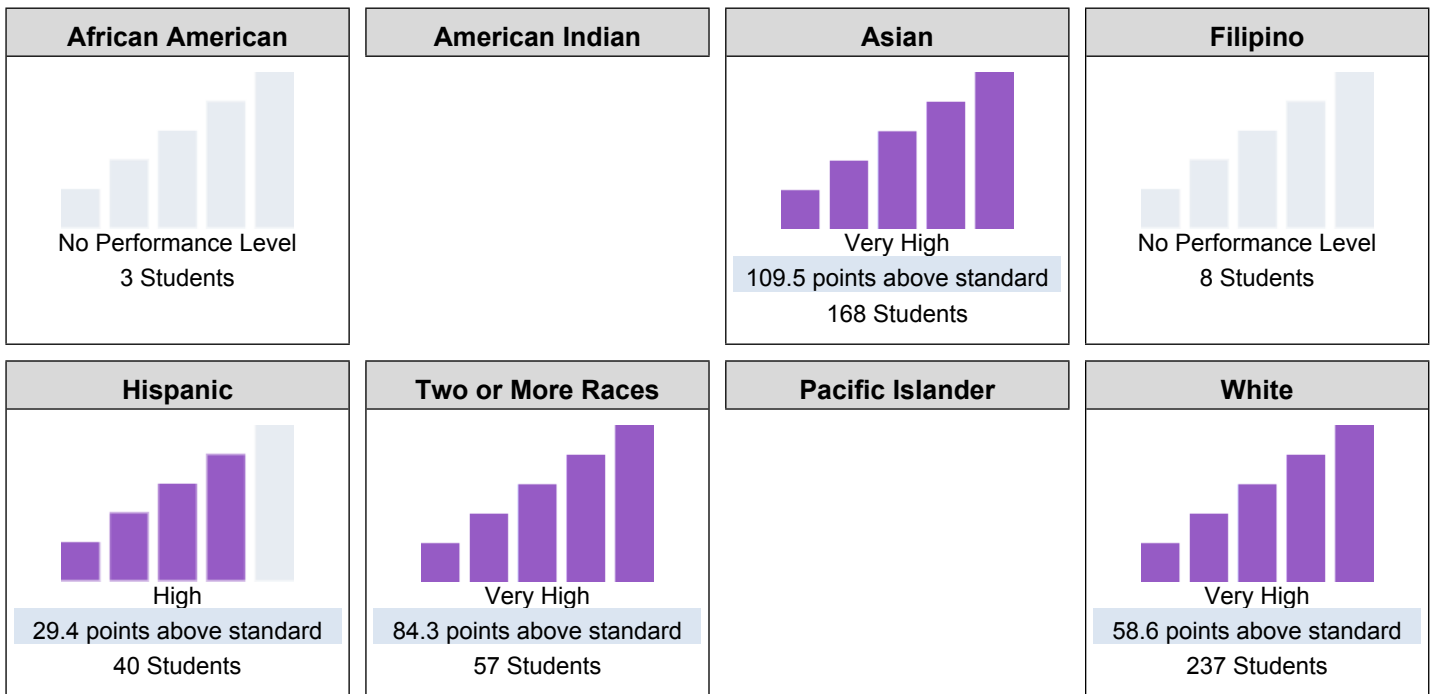

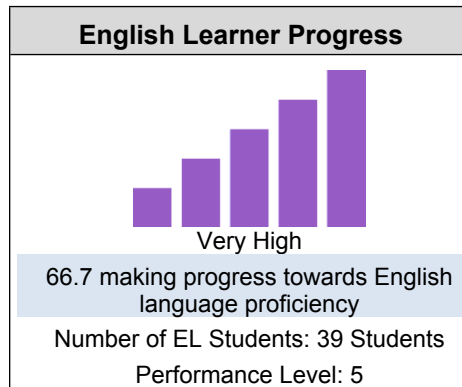

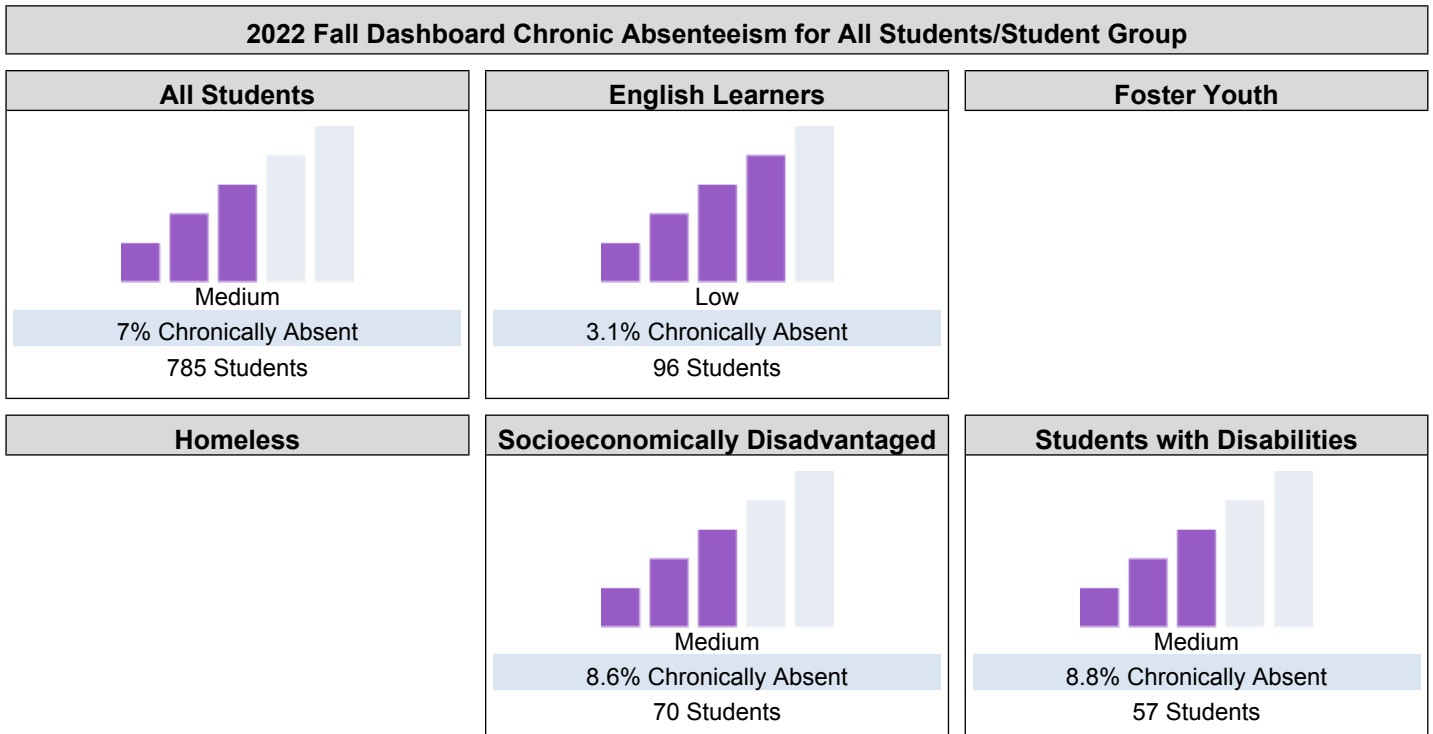

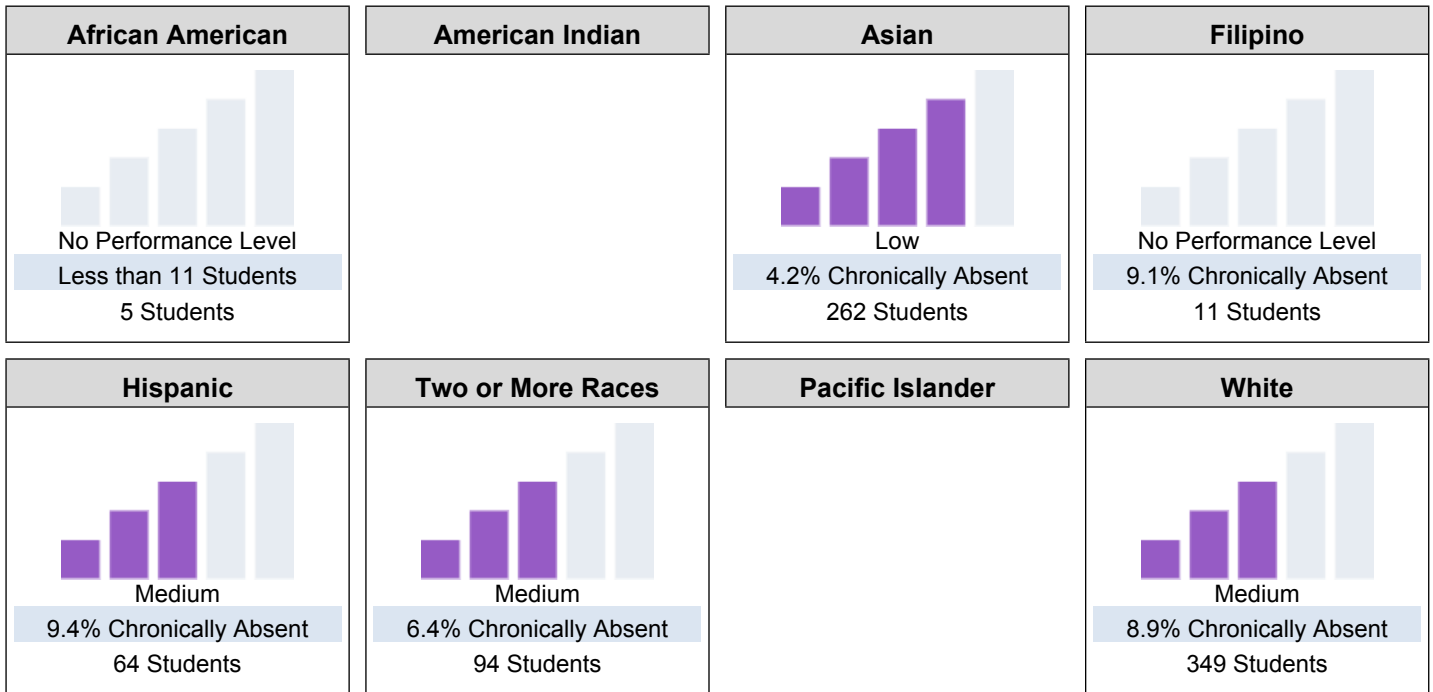

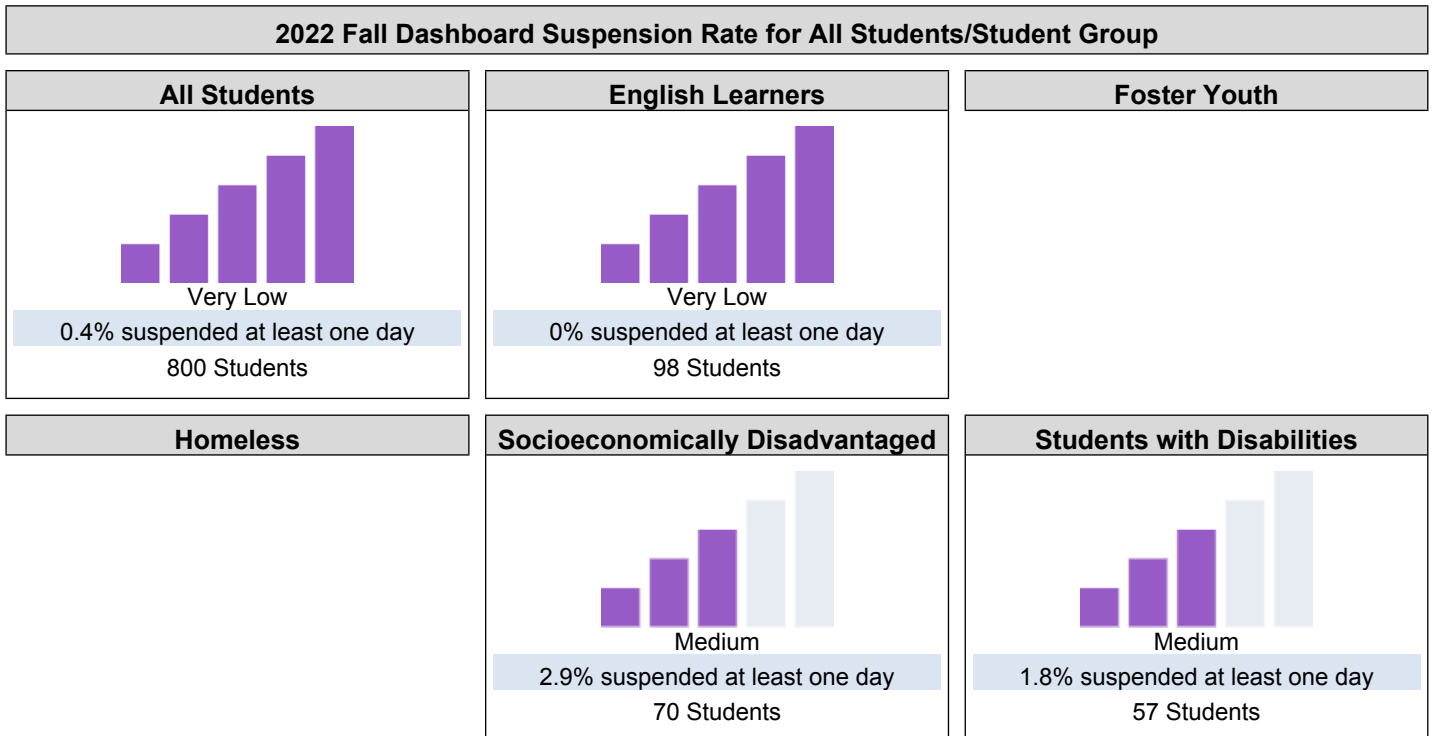

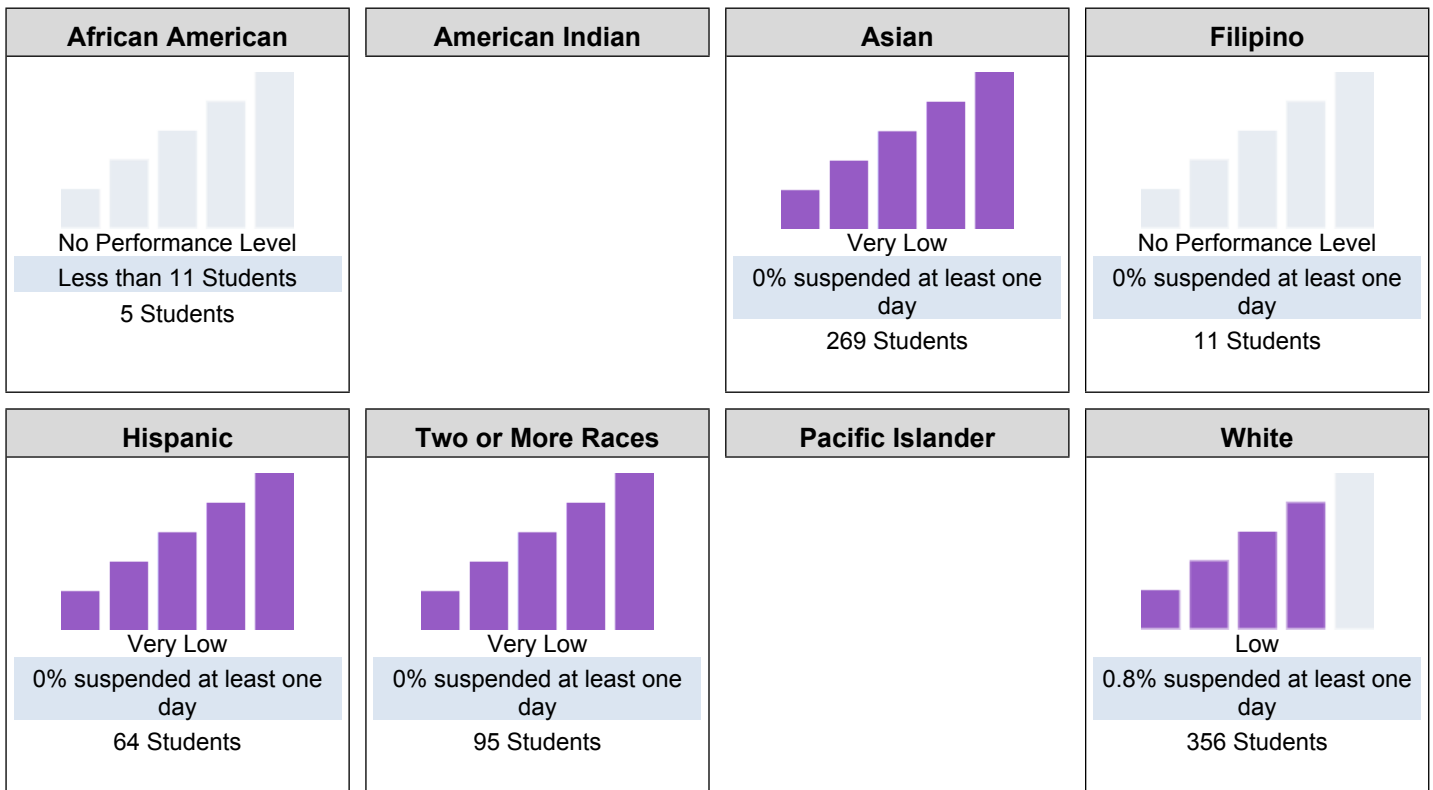
